A Regular Meeting of the Senior Advisory Sub-Committee was held on Monday, April 22, 2013 at the City Hall Commission Chambers Kitchen at 2345 Providence Boulevard, Deltona, Florida.

1. CALL TO ORDER:

The meeting was called to order at 6:04 p.m. by Lonnie Wilson, Chair.

3. APPROVAL OF MINUTES:

A. Minutes:

1. Meeting – February 25, 2013.

Motion by Mary Micelli, seconded by Marge Miller to adopt the minutes of the Regular Senior Advisory Sub-Committee meeting of February 25, 2013. There was no discussion. The motion was unanimously approved.

4. ANNOUNCEMENTS:

The following flyers/information were distributed to the members: Arbor Day.

5. PUBLIC COMMENT:

There were no members from the public present for this meeting.

6. OLD BUSINESS:

A. Discussion on development of an Arts & Crafts Fair:

The Senior Advisory Sub-Committee discussed many details of the Art Fair. Members suggested that the Art Fair be held on November 9th from 10am-3pm in the Commission Chambers as well as the Court Yard of City Hall.

Vendor fees were suggested to be \$10 for an outdoor vendor space and charging \$20 for in door.

1 Members volunteered to contact local community groups such as the Deltona Art Club and Senior
2 Communities to invite them to participate as a vendor. Mary Micelli offered to ask members of
3 C.O.A. if they would be interested in selling homemade crafts.

4
5 Rose and Marge Miller both suggested allowing two (2) food vendors for the public and offer
6 popcorn that is left over from past events. Lonnie Wilson mentioned concerns such as traffic and
7 security that would need to be discussed with staff. Mary Micelli suggested that we could name
8 the event the Deltona Art Festival, all members agreed with the name.

9
10 Members mentioned speaking with staff about seeking sponsorship to assist in advertising or
11 giveaways. Multiple forms of advertising were discussed by the Sub-Committee members such as
12 banners, flashing signs, newspapers and bus stops.

13
14 Rose Miller questioned the allowance of baked goods that were prepared at home. Members also
15 wondered if we would be able to give away popcorn during the event.

17 **7. NEW BUSINESS:**

19 **A. Planning for the Senior Breakfast:**

21 The Senior Advisory Sub-Committee began discussion on the planning of the 3rd Annual Senior
22 Breakfast. Marge Miller had followed up on contacting the Orlando Culinary School and
23 informed members that they will not be able to help us due to their summer vacation during July.
24 Rose will reach out to other culinary schools to see if they might be available to cook. Members
25 suggested changing the date to coincide with Grandparents Day in May if the schools would be
26 able to cook.

28 The members discussed increasing the price to an even \$3.00 per person. Some of the same
29 companies as before are willing to donate goods for the event. Members suggested that it is time
30 to reach out for sponsorship to help with the cost of the food.

38 a. Marge Miller informed the Senior Advisory Sub-Committee members that she had recently

42 b. Lonnie Wilson reminded the members to bring a guest to our next meeting and stated that
43 he felt the Sub-Committee has presented some great ideas for the Deltona Art Festival to
44 move ahead with.

46 c. Rose Miller is hopeful that we could get a culinary school on board for the breakfast, if not
47 for this year than for next year. She also believes that the Deltona Art Festival will bring

1 the community together as a whole for a fun filled day.
